Supra iBox BT LTE Lockbox

Under the new lockbox Library Plan, you check out lockboxes at **no charge**. You may sign out enough lockboxes to cover your listings. The iBox BT LTE has Bluetooth technology, so no fob is needed.

If your lockbox is lost or destroyed, or you fail to return your Excess Lockboxes during the September True Up period, you will be billed \$100 + tax per lockbox. *Boxes cannot be shared, transferred or sold.*

Key Options

One time GAAR set-up fee: \$16.18

eKey - for PDAs or Smart Phones

- One-time activation fee: \$50
- Billed monthly on the 5th
- Choice of either:
 - Ekey Basic - Monthly Charge: \$15.62 + tax
 - Ekey Professional - Monthly Charge: \$26.73 + tax

ActiveKey (Key pad)

- One-time activation fee: \$75
- Billed Annually – Prorated leased amount based on the monthly rate of \$18.64 / mo. from date of activation to September 5, 2018
- Insurance (optional): \$25.00/year
- Billing cycle begins on September 5th of each year
