Introduction

This report and budget provides the following information required pursuant to Section 5-11-23(F), NMSA 1978 (being a section of the Public Improvement District Act):

- Estimated operation and maintenance expenses of the district;
- Cost of public improvements to be financed by the special levy;
- All other expenditures for public infrastructure improvements and enhanced services proposed to be paid from the special levy; and
- Amounts raised to pay special levy bonds.

I. Estimated Operation and Maintenance Expenses

The Ventana West Public Improvement District (the "PID") will incur no operation and maintenance expenses with respect to public improvements. The PID will incur administrative expenses in connection with the administration of the Special Levy Revenue Bonds, Series 2004 and the billing and collection of the special levies. Please refer to Section VI for additional details.

II. Cost of Public Improvements Financed by Special Levy

The PID special levies will not directly finance public improvements. The Ventana West Public Improvement District Special Levy Revenue Bonds, Series 2004 (the "Bonds"), which are secured by the PID special levy, financed public improvements with an estimated cost of \$5,273,484.15. The Bonds were delivered in June 2004.

III. Other Expenditures for Public Improvements and Enhanced Services

There are no other expenditures for public infrastructure improvements or enhanced services.

IV. Collections

The total special levy for Fiscal Year 2014-2015 is \$646,657.80¹. For Fiscal Year 2014-2015, the County has remitted to the Trustee a total of \$629,110.82 as of June 30, 2015. As of July 9, 2015, the County's website reports special levy collections of \$643,194.26², with nine (9) parcels delinquent in the payment of either the first or second installment of the special levy for a total delinquent amount of \$3,463.54³ which equates to a 0.54% delinquency rate

Letters requesting payment of the PID special levy were sent to the delinquent property owners in mid-February and mid-July. Please refer to Exhibit A for the list of delinquent parcels.

The August 2015 payment of interest and principal on the bonds totals \$365,068.75. The PID has sufficient funds to make this payment.

VI. Amounts Raised to Pay Special Levy Bonds

The PID is projected to raise \$638,143.78 to pay for interest, principal, and the administration of the bonds and the billing and collection of the special levies. A breakdown of the amounts to be raised is shown in Table 3 below.

VII. Apportionment of Special Levy

The special levy is apportioned to each parcel in accordance with land use and development density. The maximum annual special levy amounts, as set forth in the Rate and Method of Apportionment of Special Levy, are as follows in Table 4. All properties will be classified as Subdivided Property for FY 2015-2016¹².

Pursuant to the Chapter 115 of Laws of 2015, effective June 19, 2015, property owned by a disabled veteran, as defined in the legislation, is exempt from the imposition of a special benefit assessment, including the PID special levy, if the property is occupied by the disabled veteran as the disabled veteran's principal place of residence. In certain circumstances, the property owned by a surviving spouse of a disabled veteran may also be exempt from the imposition of a special benefit assessment if he or she meets the requirements of the legislation.

A listing of the special levy amounts by the uniform property code ("UPC") that are valid for FY 2015-2016 is shown in Exhibit B.

¹² The Ventana West PID is comprised of seven (7) subdivisions. Plat recordation dates for each are as follows: April 2006 for Ventana Al Sol, February 2006 for Ventana Highlands Unit 1, March 2006 for Ventana Highlands Unit 2, April 2006 for Ventana Highlands Unit 3, March 2005 for Ventana Mesa Unit 1, March 2005 for Ventana Mesa Unit 2, January 2005 for Ventana Ridge, February 2006 for Ventana Vista, May 2005 for Western Ridge Unit 1, January 2006 for Western Ridge Unit 2, and February 2005 for Western Shadows.
