#### Q14

I have extensive experience with various MLS systems and have used them on a full time basis for over a decade. I've owned and operated successful small businesses since 1990, managed employees and finances. I've lived in multiple states, worked with agents, buyers and sellers in multiple states, all walks of life, and have a fairly wide reference base. My most recent board work was on the Upper San Juan Library District in SW Colorado where I served for 4 years, starting as director and finishing as president. As president I was instrumental in acquiring adjacent land and expanding the Ruby Sisson Library parking lot, something that had been on their wish list for many years. I currently sit on the SWMLS Policy Committee, think it does excellent work and would like to expand my role.

#### Q15

What is the role of the SWMLS and what are the challenges facing the SWMLS moving forward?

SWMLS guides the development and operation of our MLS system here in central NM, ensuring it works accurately, smoothly and usefully for subscribers (and participants). SWMLS also helps ensure the service is used properly and ethically by subscribers and there are not impediments to subscribers doing so. As with all MLS operations, our major challenge a will be the increasing potential for irrelevance of MLS systems that do not change with the times. MLS systems must recognize any light at the end of the tunnel may be an oncoming train and not the light of day if that particular MLS system is not managed well.

#### Q16

What are the strengths of the SWMLS core software and affiliated technology offerings and where do you see room for improvement and/or change?

Flex is the best of the MLS systems I've used and is solid on input and display. It's also pretty robust for statistical analysis. Infosparks, Instanet and Showingtime are very nice systems. Still, there is room for improvement in all facets of the Flex system as in any system, as long as the approach is fix only what's broken and with what's not broken, do nothing. The trick is knowing which is which.
